- i. Candidates who have paid the examination fee for I Semester are only eligible to pay II Semester exam fee and those who have paid the exam fee for the I and II Semester are only eligible to pay examination fee of III Semester and candidates who have paid exam fee for the I, II & III Semester are only eligible to pay the Exam fee of IV Semester.
- ii. Without payment of Tuition Fee of the Semester the Exam form will not be accepted.
- iii. Examination Fee once paid will not be refunded.
- iv Examination Centre will be at Hyderabad & Secunderabad (Twin Cities).
- v. The University reserves the right to cancel the admission / results of the candidates at any stage when it is detected that his / her admission is against the rules.
- vi. <u>The candidates who have completed FOUR YEARS period from the year of registration i.e.</u> whose <u>Hall ticket No. begins with 094-21-0000</u>
- a) Who desire to appear for aggregate improvement after completed (I, II, III & IV Sem.) and also who have not yet completed M.C.A. Course i.e., having backlog papers either in I, II, III & IV Sem. are also eligible to register their forms for 2025 examination provided they pay Re-registration fee of **Rs.1500**/- along with the prescribed exam fee. Copy of Re-registration fee receipt must be enclosed with the exam form.
- b) The candidates who have completed FOUR YEARS period from the year of registration and registered for M.C.A. I Semester examinations, but not registered for II and IV Sem. examinations, have to pay reregistration fee of Rs.3000/- for permission to appear for their II or IV semester exams in addition to the normal exam fees.
