I. ABOUT THE OSMANIA UNIVERSITY

The Osmania University, established in 1918, is the seventh oldest in the country, third oldest in South India and the first to be established in the princely State of Hyderabad. Though the need for a university for the Hyderabad State was felt, both by the intelligentsia and the people for a long time, the initiative came from a civil servant, Sir Akbar Hydari, who was then the Home Secretary to the State Government. Sir Hydari, in a Memorandum to the Education Minister in early 1917, emphasized the need to establish a University for Hyderabad with 'Urdu' as the medium of instruction "as it is the language of the widest currency in India, official language of the State. and it is a language which is understood by a vast majority of the population of the State" He believed that higher education must have its foundations deep in national consciousness.

The propitious moment, however, came a few months later on 26th April 1917 when a Firman was issued for the establishment of the University. The Firman also detailed the 'Mission ' and 'Objectives' of the University to be that:

- the ancient and modern, the oriental and occidental arts and sciences are synthesized in such a manner that the defects of the present system of education are rectified.
- the ancient as well as modern methods of physical, intellectual and spiritual education are to be fully utilised along with an effort for the propagation of knowledge, the moral improvement of the students is regulated on the one hand, and research work of a high order in all branches of knowledge is conducted on the other.

Though the medium of instruction of the University was 'Urdu' an Aryan language that has direct Kinship with other languages of the country, instruction of English, as a language, was made compulsory for each student.

One of the basic ideals of Osmania University is to achieve an intellectual synthesis of oriental and occidental learning of the best that has been thought of and said, both in the East and in the West. Further, it aims at a cultural synthesis (as reflected in its architectural variety), the development of a national ethos, and the creation of an academic and social environment in which 'National Integration' is not a nebulous idea but a tangible reality.

VISION OF THE UNIVERSITY

The Vision of the University is to generate and disseminate knowledge through a harmonious blend of ancient and modern wisdom, and to serve the society by developing in students heightened intellectual, cultural, ethical and humane sensitivities; to foster a scientific temper, and to promote professional and technological expertise. Central to this vision is a commitment to regional and national development in consonance with our culture, heritage and environment.

II. ABOUT THE PGRR CENTRE FOR DISTANCE EDUCATION, OSMANIA UNIVERSITY

The PGRR Centre for Distance Education, Osmania University was established in the year 1977. Ever since the Osmania University established the Centre for Distance Education, the Centre has witnessed phenomenal growth and emerged as a pioneering institution in the field of Distance Education, with Potential for Excellence. The Centre has been named after Prof. G. Ram Reddy who was the doyen of Distance Learning in India and also the Vice Chancellor of Osmania University for two terms. He was the founding Vice Chancellor of first Open University in India in 1982, then known as Andhra Pradesh Open University (Dr. B.R. Ambedkar Open University) and Indira Gandhi National Open University. (IGNOU), Vice President of the Commonwealth of Learning (COL) Vancour, Canada, apart from being the Chairman of UGC and Chairman of the Indian Council of Social Science Research (ICSSR).

The functions of Centre for Distance Education include:

- To provide a system of learner centred self-paced studies;
- To provide flexible, diversified and need based courses;
- To provide access to higher education for all, in order to realize' Higher Education For All (HEFA);
- To facilitate Open and Distance Learning for the benefit of those persons not able to pursue their education through regular mode.
- To offer Open Distance Learning and Online courses in emerging and job oriented courses; and
- To facilitate knowledge acquisition throughout one's life and be an active member in a knowledge society.

At present the student support services at the Centre for Distance Education are essentially based on the supply of reading materials for home study by the learner, supported and supplemented by facilities, like study Centres or Authorised Learning Centres. This is found

to be well received from student target groups. The Distance Education mode with interactive learning system at the core is the need of the day.

INSTRUCTIONAL SERVICES:

1) MEDIUM OF INSTRUCTION:

The medium of instruction for our courses will be either English or Telugu or both depending on the course as specified in this Prospectus.

2) COURSE MATERIAL:

Printed course material is provided for all the courses. It may be supplemented / substituted by e-material and links to e-resources on the subject.

3) LIBRARY AND COMPUTER LAB FACILITIES:

The Centre for Distance Education provides excellent study facilities to assist students' learning. The CDE library is located at its campus. Course materials, reference books (prescribed, suggested and additional), audio - visual material and journals are available in the library.

The Centre has an excellent Computer Lab, with LAN and is being presently used to offer computer courses. Efforts are being made to make all the courses on-line through multi-media course material.

4) **RECOGNITION OF MERIT**:

CDE has established gold medals to be awarded to meritorious students of some of the UG and PG courses.

INTERNAL ASSIGNMENTS:

All the students enrolled in different courses of **Prof. G. RAM REDDY CENTRE FOR DISTANCE EDUCATION** should write and submit **Internal Assignment** for each paper which is compulsory. Each assignment carries 20 marks (for MBA/MCA/BBA 30 marks). The marks awarded to the students will be forwarded to the **Controller of Examination**, OU for inclusion in the Memo of Marks along with the Marks obtained in the Year-end Examination conducted by the **University**. The candidates have to pay the internal assignments fee along with the payment of the examination Fee. He will not be given an opportunity to submit the internal assignment in subsequent years if he / she fails to submit internal assignment before the stipulated date. It will not be accepted and the candidate has to forego the assignment marks.

- 16. Those who submit the admission form Online can collect the study material from the Study Material section by showing the Online fee receipt and Identity Card. Those in second year, who paid the fee through Online, can also collect the study material from the Study Material section by showing the Online fee receipt/Acknowledgement.
- 17. All matters relating to examinations/ results / marks / certificates will be dealt with only by the Controller of Examinations, Osmania University, Hyderabad-7.

- 19. Every candidate once admitted shall have to pay the fee for the whole year. If the candidate desires to discontinue the course and obtain the Transfer Certificate in the middle of the academic year or in subsequent years, has to pay the fee for the whole year.
- 20. Late fee will be charged after the due date of payment of Tuition fee
- 21. The Examination fees has to be paid by the candidates as and when the notification is issued for the payment of Exam fee for various courses

- 22. Annual examinations normally will be held during June / July for PG courses, and semester Examinations for MBA course are normally held in the month of May (I & III semester) and September (II & IV Semesters). For Graduate courses (BA/B.Com./BBA) the examinations are conducted along with the regular course.
- 23. Change in address and mobile number, if any, should be immediately communicated to the Centre.
- 24. For all legal matters the jurisdiction is restricted to Hyderabad City only.
- 25. Candidates are advised to be very clear in the choice of their course at the time of admission. Choice of course of study once made, will be final and NO change of subject will be entertained.
- 26. According to the norms of the University, a candidate who completes his Degree in Supplementary Examinations will NOT be eligible for admissions in PG course in the same academic year.
- 27. The students of the PGRRCDE are not eligible for bus pass facility & Hostel Accommodation. Further, that they are also not eligible for any other Scholarship from Govt. / University.
- 28. Candidates who have studied a part of their course through PGRR Centre for Distance Education will not be permitted to seek admission to the regular college under the jurisdiction of the Osmania University.

GENERAL ELIGIBILITY CRITERIA

- 1) There is no age restriction for admission to any course.
- 2) Candidates will be admitted without any Entrance Test provided the candidate fulfils the requisite qualifying conditions mentioned for the course. (Except MBA & MCA courses for which entrance requirement is prescribed).
- 3) The PGRRCDE, OU offers the ODL courses strictly in accordance with the norms of UGC (ODL) Regulations 2020, Annexure-III regarding the territorial jurisdiction.
- 4) Candidates from abroad are also eligible for admission to all courses provided:
- a) They fulfill the requisite qualifying conditions mentioned in the prospectus.
- b) They furnish an address in INDIA for correspondence and dispatch of study material and information.
- c) PGRRCDE does not entertain any correspondence on foreign address.
- d) They should come to Hyderabad for writing the examinations till they complete the course.
- 5) Candidates who have passed the qualifying examination conducted by the Board /University which are under the jurisdictional area of other States shall have to obtain an Eligibility Certificate from the Deputy Registrar (Academic), Osmania University to the effect that they are eligible for admission into the university courses.

ELIGIBILITY:

M.A. English / Hindi / Sanskrit / Telugu / Urdu :

A candidate should have passed U.G. Degree Examination and studied the subject concerned at UG Level. B.E. / B.Tech / BCA candidates are eligible to pursue MA (English) course. Those who have passed P.G. Diploma in Sanskrit or its equivalent are eligible for M.A. (Sanskrit).

M.A. Economics / Political Science / History :

A Candidate should have passed Graduation / Degree Examination and studied the subject concerned at UG Level. B.Com Graduates are also eligible to take admission in MA (Economics).

M.A. Public Personnel Management / M.A. Philosophy / M.A. Sociology / M.A. Public Administration:

A candidate should have passed any UG (3 years duration) Degree examination.

M.A. Psychology:

A candidate should have passed UG (3 years duration) Degree Examination with Psychology as one of the subjects in BA or Bachelor of Mentally Retarded (BMR) / Bachelor of Social Work (BSW)/ M.Ed. / MA (Education)/ M.Sc. (Home Science)/ Diploma in Child Psychology/ Diploma in Industrial Psychology.

M.Com.: A candidate should have passed B.Com. (3 years duration)

M.Sc. Mathematics:

A pass in B.A./B.Sc. (3 years duration) / BE / B.Tech and should have studied the Mathematics as one of the subjects at UG level.

Those who have passed P.G. Diploma in Mathematics or AMIE Degree Course in Mechanical Engineering Examination conducted by the Institute of Mechanical Engineers, Bombay, are also eligible to pursue M.Sc.(Maths).

M.Sc. Statistics:

A pass in B.A./B.Sc. (3 years duration) and should have studied Mathematics / Statistics as one of the subjects at UG level. The Candidates who have passed B.E./ B.Tech are not eligible.

DIRECT ADMISSION TO SECOND YEAR

The following categories of P.G. students are only eligible for direct admission to the second year of the two year courses.

- i) A Post Graduate candidate who withdraws from a regular college of the Osmania University after completion of her/his first year can seek admission directly to the second year with due permission from the **Registrar (Academic)**, **O.U**.
- ii) Students of the Osmania University with a back-log of subjects in one or two or even all papers (i. e. both promoted and failed students) in the first year will also be admitted directly to the second year with due permission from the **Registrar (Academic), OU**

VERIFICATION OF ORIGINAL CERTIFICATES:

After the registration the students are required to approach the PGRR Centre for Distance Education, Osmania University Campus or nearest study Center for the Certificates verification. Students are required to submit all their original certificates for verification. The following certificates are essential to take admission in P.G. course :

- (i) Original Memo of Marks of Qualifying examination (BA/B.Com./B.Sc./B.Tech/B.E.Degree Examination)
- (ii) Transfer certificate in original from the college last studied (Not returnable)
- (iii) Degree Provisional/ Convocation Certificate.
- (iv) S.S.C. and Intermediate certificates.
- (v) SC/ST/BC/PHC certificates (If applicable)
- (vi) Migration Certificate in original (not returnable), in case the candidate has passed the qualifying Examination from Universities in Indai, other than 0smania University. along with a fee for Rs.125/-. A candidate who fails to submit Migration Certificate (as some of the Universities are not issuing Migration certificate) will be charged a fee of Rs. 425/- in lieu of Migration Certificate.

MEDIUM OF INSTRUCTION AND STUDY MATERIAL

METHOD OF INSTRUCTION

I) Study Material: The Self- Instructional study/ course material for each paper consists of about 30 lessons. The students who take admission in person can collect the material in person by showing the fee receipt and Identity card from the material section of the centre, on the same day. In respect of the other students, the material will be sent by post depending on the mode of payment of their tuition fee.

CONTACT CLASSES:

Contact between teachers and the taught will be provided by arranging the Contact cum-counseling classes for a period of 10 to 15 days at the end of the academic year and prior to the Annual Examinations. Students should produce their identity card for attending these classes. No Hostel / boarding arrangements will be made by the Centre and the

students have to make their own arrangements for staying in Hyderabad / District study centres for attending these contact classes.

PYSCHOLOGY PRACTICAL CLASSES:

The Practical classes will be conducted at PGRRCDE, O.U. Campus, Hyderabad, for M.A. Psychology I & II year prior to the Annual Examinations. It is compulsory for all the students to attend these practical classes conducted for 5 days.

Note : The students of the courses having Practical Examinations have to pay the fee of Rs.500/- (per year) in addition to the normal Exam fee.

COMPULSORY

Attending all Practical classes in a batch in which the candidate is included, is compulsory for appearing M.A. Psychology (Pre) (Paper-V) Practical Examinations

COMPULSORY

Attending all Practical classes in a batch in which the candidate is included, is compulsory for appearing M.A. Psychology (Final) (Paper-V) Practical Examinations.

COMPULSORY

Attending theory - cum - experimental learning contact classes of M.A. Psychology (Final) Elective Papers {III A and IV A/ (OR) III B and IV B} is compulsory for appearing theory exams in the papers concerned.

EXAMINATIONS

1) Rules of Examination:

Examination fee payment details can be obtained by the candidates through PGRRCDE website: **www.oucde.net**

Note : The students of the courses having Practical Examinations have to pay the fee of Rs.500/- (per year) in addition to the normal Exam fee.

2) Scheme of the Examination:

- There is no "detention" system in Distance Education. Students who have failed will be allowed to continue the course of study for the next year.
- In case of PG courses, they have to complete the course in four academic years from the date of joining. Those who could not complete the course within four years, have to re-register by paying Rs.500/- for every year. Those who have paid the examination fee both for previous and final year but failed to appear/appeared and failed only are eligible for "Re-Registration".

The candidates who have completed four years period from the year of Registration and have registered to M.A., M.Com., M.Sc. (Maths) and M.Sc. (Statistics) Previous examinations but not registered for Final year examinations, have to pay **Re-Registration** fee of **Rs. 1000/-** for permission to appear for their Final year exams in addition to the normal exam fee.

Candidates who have completed four years period from the year of registration and paid term fee for previous but not registered for Previous examinations, by paying Rs.1000/ towards Re-Registration fee for permission to appear for the previous examinations and they are eligible to write the final year examinations in the next academic year by paying Rs.500/ every year towards Re-Registration fee in addition to the normal examination fee.

Candidates appearing for P.G. Examinations should register for PREVIOUS examinations first. They cannot appear for both Previous and Final Year examination simultaneously unless they register for PREVIOUS examination in the preceding year.

Internal Assignments :

Every student of M.A./M.Com./M.Sc. I & II Year who have paid Examination Fee for the First time only have to write and submit Assignment for each paper compulsorily for that Year Only. Each assignment carries 20 marks (for MBA/MCA/BBA 30 marks). University Examinations will be held for 80 marks (for MBA/MCA/BBA70 marks). The concerned faculty evaluates these assignment scripts. The marks awarded to you will be forwarded to the Controller of Examination, for inclusion in the University Examination marks. If you fail to submit Internal Assignments before the stipulated date, the internal marks will not be added to University examination marks under any circumstances. Rules for Improvement:

Paper-Wise Improvement:

Paper-Wise improvement is permissible either in the individual paper or in the whole of an examination, only when he / she has passed in the first attempt, conducted by the University for that batch of Regular students admitted to the course along with him/her.

- i. Candidates are permitted to appear for paper-wise improvement only once for previous and once for final year examination under year-wise scheme.
- ii. Candidate who wishes to improve his / her performance, whether in the Previous or Final year examination is required to do so by appearing in the next immediate regular examination, along with the next batch of regular students, conducted by the University. Even if a student has passed in one or two or three papers in the previous or final years in their first attempt, can appear for paper-wise improvement along with backlogs (i.e., along with failed papers) in the next immediate examination. Paper-wise improvement is not permissible on completion of any backlog papers.
- **Note:** Backlog means those who have registered for the examination but absent in one or more papers, or failed in any paper or not registered for the examination along with his/ her batch of students.
- iii. Candidates appearing for paper-wise improvement are permitted to retain the better of the two performances in individual papers, for the purpose of award of division.

Aggregate Improvement:

When the Candidates exhausted the chances of paper-wise improvement of previous/ final years, the candidates shall be permitted to appear for aggregate improvement as per the following conditions.

- i) The aggregate improvement is permissible only if he / she appears for the whole examination and not in individual papers. The candidate can appear either for previous or final or for both under year-wise scheme of examination. The candidates have to appear for improvement examinations as per the scheme and syllabus in vogue at the time of taking the examination.
- ii) When the candidate appears for the whole examination either in previous or final year both for aggregate improvement, he/ she shall have the OPTION to retain the better of the aggregate marks of the two examinations taken as a whole and not the better performance in individual paper (s).

Further, the candidate is allowed to appear for aggregate improvement either in previous or final or both but not exceeding (2) chances in previous or final year each.

iv) Candidates who appear for improvement of performance under the above two categories are not eligible for the award of Distinction/ Prizes/ Merit Certificates etc.

ENROLMENT NUMBER AND IDENTITY CARD

- Every candidate who is admitted to the PGRR Centre for Distance Education will be assigned an Enrolment Number which will hold good during the entire period of the course. In all communications the student must invariably mention this enrolment number in full. Correspondence without enrolment number will cause delays and difficulties both to the Centre and the student and at times the Centre may not be in a position to respond. The Enrolment Number will also be used in the examination as Hall Ticket number.
- Every candidate admitted at the centre will also be supplied with an Identity Card by the Centre with the enrolment number. This card must be produced whenever required by the authorities at the time of Contact cum Counseling Session, University Examinations, and at Library. If the Original Card is lost, a duplicate card will be issued on remittance of Rs.100/- through On-line payment. At the time of taking Degree Certificate ID Card should be submitted to the Examination Branch.

The candidates to obtain these certificates by post are required to Pay **Rs.75/-** towards Postal charges in addition to the prescribed fee for the certificates through online.

Transfer of students from Regular college to PGRRCDE in MBA/ MCA is allowed with due permission of the Dy. Registrar, (Academic), OU. However, there is no transfer of M.B.A./M.C.A. students of PGRRCDE to regular college.

(I) Migration Certificate in original (NOT Returnable), in case the candidate has passed the qualifying Examination from Universities in India, other than Osmania University. A candidate who fails to submit Migration Certificate (where the Universities are not issuing Migration certificate) will be charged a fee of Rs. 425/- in lieu of Migration Certificate.

(G) MEDIUM OF INSTRUCTION AND STUDY MATERIAL

The medium of instruction and the Study material for M.B.A./ M.C.A. is offered only in English Medium.

(H) METHOD OF INSTRUCTION

i) Study Material

The Study/Course Material for each paper consists of about 30 lessons. This material is normally dispatched to the students in one or two installments. The students who take admission in person can collect the material in person by showing the online fee receipt and Identity Card from the material section of the centre.

ii) Contact Programme:

Contact between teachers and the taught will be provided by arranging the Contact cum-counseling classes on Second Saturdays and Sundays for M.B.A / M.C.A. students. The venue of the classes exact dates, and timings of the commencement of contact classes will be intimated to the candidates through SMS alerts to their Mobile Number. Students should produce their identity card for attending these classes. No Hostel/ boarding arrangements will be made by the Centre and the students have to make their own arrangements for staying in Hyderabad.

(I) **EXAMINATIONS**

i) Rules of Examination:

- There will be University Examinations at the end of each Semester.
- The minimum pass marks in each paper as well as aggregate is 40%.

ii) Scheme of the Examination:

- There is no "detention" system in Distance Education. Students who have failed also will be allowed to continue the course of study for the next year.
- However they have to complete the course in four academic years from the date of joining for two year Course. Those who could not complete the course within four years, have to re-register by paying Rs.500/- every year in addition to the normal examination fee. Those who have paid the examination fee four years but failed to appear/appeared and failed only are eligible to "re-registration". If they could not take benefit of this they have to take fresh admission.
- Semester wise Students have to complete the course in Four years, after they have to Re-Register by paying prescribed Fee.
- Those who have paid the examination fee for 1st year/semester are only eligible to pay II year/semester exam fee and those who have paid the exam fee for the I and II year/semester are only eligible to pay examination fee of III year/semester.

- iii) Further, the candidate is allowed to appear for aggregate improvement either in First, Second, Third and Fourth Semesters but not exceeding (2) chances in each First, Second, Third and Fourth Semesters within the stipulated period of FOUR years after passing the First, Second, Third Fourth Semester examinations.
- iv) Candidates who appear for improvement of performance under the above two categories are not eligible for the award of Distinction/ Prizes/ Merit Certificates etc.

Note: These rules for improvement may change from time to time.

d) GUIDELINES TO MBA STUDENTS FOR PROJECT REPORT

In all professional courses it is customary to insist on a Project Report. This is a worldwide fact aimed at preparing the students to get the taste of the real life situations in the profession they have chosen to pursue.

Project work is aimed at preparing the MBA students in understanding the application value of the principles and paradigms they have studied as part of their Two - year Programme. The objective of this is to offer them guidelines to select a topic (list of suggested topics given as Annexure-V) of their choice or choice of the organization where they want to study finalized in consultation with their project guide. If they follow these guidelines carefully the objective of preparing them for report writing will also be achieved because preparing reports is an essential activity of any business manager. The format for project report given here is universally accepted and if they follow this format carefully it will facilitate their examiner in the evaluation of this report which carries grades A to D. It may be noted that they can show their project report with confidence and pride to their prospective employers (Selectors) if they have worked carefully on their project report.

A managerial research is generally conducted to probe into a management problem resulting in a research report. It means that a research report is the end product of a research. On the other hand a business report or a management report is a report prepared by the management to portray certain important aspects or problems in business. Thus, two important types of report in the realm of management are: (1) business report or management report, and (2) managerial research report. Your project report could be any one of them or could be both if some organization requests you to study some problems of their organization.

METHODOLOGY

Business research starts with report planning, which includes a determination of the objectives of the report, identification of the target reader of the report, consideration of the real purpose of the report, planning for the collection of proper materials for the report, preparation of the scheme of report writing, planning for proper utilization of time in report writing, and crystallization of the actual lay out of the report.

Once the report is planned, material collection starts. Checking and rechecking of materials collected against the actual objectives and layout of the report then become necessary. Arranging the contents of the report should also not be forgotten. When the collected materials, data, observation, documentation, information, opinion, clarification, etc., are arranged and fitted together to a carefully articulated form, the writer will come to know as to which materials to put together in the report, and what is to be dispensed with. It should, however, be ensured that enough material has been selected to carry out the purpose of the report. When the prospective reader is less familiar with the situations and specifications than the writer, the writer must ensure that all the necessary details are given in the report. But the information must be to the point and in accordance with the needs of the reader. Beating about the bush must be avoided.

As soon as proper data and information are collected, selected, and arranged, adequate thought must be given to the purpose of the report that is: what is to be communicated? To whom it is to be communicated? When is to be communicated and for what purpose? The report writer should place himself in the shoes of his reader (examiner) before he starts writing. Ask this question: how would he/they react if I gave a short slant to the arguments in this fashion? Think over it, try to rearrange your materials, and then start writing the report. This will enable you to determine what should find a place in your report and where: and what must not be included in it. It is the report writer who will have to decide about what is to be included in the report to make it effective. The more one is experienced, the more will one form, be effective on report writing. Generally speaking the following may be the contents of a report:

- 1. Title page
- 2. Letters of authorization
- 3. Table of contents, statistical tables, charts and illustrations
- 4. Introduction Need, Objectives
- 5. Methodology
- 6. Findings

- 7. Limitations
- 8. Summary and Conclusions
- 9. Recommendations
- 10. Appendices
- 11. Bibliography
- 12. Index of key words used in the report

In table of contents an outline of the report, which contains major headings and subheadings, as well as the various sub - sections are presented. There should be a summary of the report, especially when the report runs into many pages. The summary provides a reasonably complete resume of the report. And it helps the reader to grasp what is important in the report.

The body of the report is its chief part. It includes everything from the statement of the problem to a detailed analysis of the data and information. Statistics, documentation, and information are presented for analytical purposes. Everything should be organized in an elegant manner. This should be followed by conclusions, suggestions and recommendations

NATURE OF THE PROJECT

The project work you are undertaking may be :

- a) either a case study of a problem or practices in an organization (S)
- b) comparative study of two organizations or within an organization its performance during different periods.

It may be based either on primary data (data the student is collecting) or secondary data (data already available) or both (books/documents etc)

PROJECT SUPERVISOR / GUIDE

The Project guide will be allotted by the Director, PGRRCDE, OU from among the following. You should contact the concerned Project guide only between 10.00 am to 6.00 pm on phone:

- a) An Academic Counselor of PGRRCDE, O.U. OR
- b) A member of the Faculty of O.U. I or its Affiliated Colleges.

SELECTION OF TOPIC

A student can choose any topic of his/ her own choice. In case, the students want to work in areas like General Management, Production Management, Operations Research, MIS, TQM, etc. they can choose a topic from those areas after consulting their guides. But if the students want to work in specialization areas, viz, Finance, Marketing and Human Resource Management, then the area topic they are selecting for project work should correspond with the specialization area opted by them in their final year MBA Programme

SUBMISSION OF THE PROJECT PROPOSAL

Students have to finalise the topic and synopsis (of not more than 5 typed pages) of the project in consultation with their Guide and send the same along with the duly completed Project Proposal Proforma (see Annexure-II) in triplicate to the Director, PGRRCDE, O.U. HYD - 500 007. for approval. The Bio - data of the eligible guides should also be sent along with this proposal for approval, if necessary.

The synopsis you are sending should be in the format enclosed (Annexure-III)

You are requested to send one self - addressed envelope along with the synopsis to the Department.

Before sending the Synopsis ensure that:

- It is in the paper format
- Project Proposal Proforma in triplicate duly signed by the Project Guide is enclosed. (Annexure – I)
- One self addressed envelope is enclosed.

COMMUNICATION APPROVAL

A written communication regarding the approval of the synopsis and also the eligibility of the guide (if applicable) will be intimated to the students within four weeks from the last date for submission of the synopsis. In case the synopsis is not approved, the reasons for the same will be communicated to the students. Such students, whose synopsis is not approved have to resubmit the revised synopsis along with the Project Proposal Proforma duly signed by the Project Supervisor and the candidate, to the Director, PGRRCDE, O.U. HYD. within one month from the date of communication or as per the date mentioned therein.

PREPARATION AND SUBMISSION OF PROJECT REPORT

- a) The Project report may consist of 50 to 100 pages (including the appendices, exhibits etc.) depending on the scope of the topic.
- b) The candidate has to mention the research methodology he/she proposes to follow in the sample selection and collection of data.
- c) The report should be compulsorily be typed on the bond papers in double space.
- d) The Project Report fee should be paid Online only, along with IV Semester Exam fee.
- e) The project report should contain the following three certificates: they are:
 - i) The approval for the synopsis received from the PGRRCDE, O.U.
 - ii) Certification given by the Project Guide that the student worked under his / her guidance (Annexure-IV)
 - iii) Declaration by the student stating that the work is an original one and has not been submitted to any University or Institution for the fulfillment of the requirement of a course of study (Annexure- V). Annexures IV and V have to be enclosed only to the final Project Report but not to the synopsis.
- (f) Synopsis received after the last date will not be accepted.
- (g) Submission of the project report is a pre-requisite for writing the final year examinations.
- (h) As the project report will not be returned to the students they are advised to keep one copy of the report for themselves.

EVALUATION OF THE REPORT

The project report submitted by the candidates will be evaluated by an examiner other than guide.

GRADE FOR THE PROJECT WORK & VIVA – VOCE EXAMINATION

The students have to attend Viva - Voce Examination (Compulsory) after the completion of the IV Semester end examinations, which will be based mainly on project work. The Grades for Project Work and Viva - Voce Examination are A to F.

(IV) Rules for Improvement:

a) Paper-Wise Improvement:

Paper-wise improvement is permissible either in the individual paper or in the whole of an examination, only when he /she has passed in the first attempt, conducted by the University for that batch of students admitted to the course along with him/her.

- i. Candidates are permitted to appear for paper-wise improvement only once for First year examination under year-wise scheme.
- ii. Candidate who wishes to improve his / her performance, whether in the I year or II year examinations is required to do so by appearing in the next immediate regular examination, along with the next batch of students, conducted by the University. Even if a student has passed in one or two or three papers in the First and Second years in their first attempt, can appear for paper-wise improvement along with backlogs (i.e., along with failed papers) in the next immediate examination. Paper-wise improvement is not permissible on completion of any backlog papers.

Note: Backlog means those who have registered for the examination but absent in one or more papers or failed in any paper.

iii. Candidates appearing for paper-wise improvement are permitted to retain the better of the two performances in individual papers, for the purpose of award of division.

b) Aggregate Improvement:

When the Candidates exhausted the chances of paper-wise improvement of First and Second, years, the candidates shall be permitted to appear for aggregate improvement as per the following conditions.

I) The aggregate improvement is permissible only if he / she appears for the whole examination and not in individual papers. The candidate can appear either for First, or Second for all the Two years under 4 Semesters scheme of examination. The candidates have to appear for improvement examinations as per the scheme and syllabus in vogue at the time of taking the examination.

- ii) When the candidate appears for the whole examination either in First or Second, years for two years aggregate improvement, he/ she shall have the OPTION to retain the better of the aggregate marks of the two examinations taken as a whole and not the better performance in individual paper (s).
- iii) Further, the candidate is allowed to appear for aggregate improvement either in First or Second for Three years but not exceeding (2) chances in each First and Second years, within the stipulated period after passing the first and second year examinations.
- iv) Candidates who appear for improvement of performance under the above two categories are not eligible for the award of Distinction/ Prizes/ Merit Certificates etc.

Note: These rules for improvement may change from time to time.

The candidates are advised to contact the examination section regarding the examinations and improvement for correct / updated details.

VII. ENROLMENT NUMBER AND IDENTITY CARD

I. Eligibility:

- Candidate shall be admitted to the three year B.A./B.Com./ B.B.A.(Degree) Course if he/she has passed the Two Year Intermediate examination conducted by the Board of Intermediate Government of Telangana or Higher Secondary Certificate examination of the Government of Telangana (XI I standard) or Pre-University Examination of this University or an examination recognized as equivalent thereto. For **B.A. (Mathematics & Statistics)** a candidate should have studied Mathematics or Statistics as one of the optional at Intermediate or its equivalent.
- A candidate who passed any Diploma course through Polytechnic of Telangana is eligible for admission into B.A./ B.Com./B.B.A. I year. However, the ITI certificate holders are not eligible for admission into B.A./B.Com./B.B.A. I year.
- A candidate who did 10+2 from National Open Schools or a diploma in any course from any polytechnic or 10+2 other than one in Telangana should obtain equivalent certificate from Board of Intermediate Govt. of T.S., Hyderabad, to the effect that they are eligible for admission in to the University courses.

ii) For Admission to the Second / Third Year of Degree Courses:

- A candidate who withdraws from a regular college of Osmania University after completion of his/her first year or second year can seek admission in second year or third year as the case may be, with due permission from the Deputy Registrar, (Academic), OU. The backlog papers should be cleared from the college where studied or PGRRCDE in case of any difference paper it should be cleared from PGRRCDE.
- Students of Osmania University with a back-log of subjects in one or two or even all the papers (i.e., both promoted and failed students) in the first year or second year stage, will also be admitted directly to the second or third year of study, as the case may be. The back-log papers should be cleared from the PGRRCDE in the Supplementary or the following Annual Examination.

iii. IMPORTANT INSTRUCTIONS FOR STUDENT ON BEING TRANSFERRED TO PGRRCDE

The transferred students of Affiliated colleges of O.U. or other Universities seeking admission into BA. B.Com. BBA II & III year should compulsorily have to pass the following papers:

- (1) Indian Heritage and Culture & Fundamentals of Human Values and Professional Ethics in 1st year
- (2) Environmental Studies in second year (3) Science & Civilization in III year and have to register for the above subjects with separate examination fee and form failing which their degree will not be issued. In both the above cases, admissions will be accorded, provided the combination of the group subjects offered, Second Language offered and the medium of instruction offered by him, in the regular college are the same as those offered in the Prof. G. Ram Reddy Centre for Distance Education. Those students who completed DCCP (three years course) are eligible for admission into II year of B.Com.

However, they have to clear the Five papers mentioned in the orders issued by Dy. Registrar, Academic Branch, O.U.

- A Post-Graduate / Honours Candidate / Graduate of Arts / Social Science / Science / Commerce of any University in India desirous of doing a Second degree course other than the one done by him / her earlier, can seek admission to the second year of BA/ B.Com. Course with exemption of language subjects with due permission from the Deputy Registrar (Academic Branch) O.U. Such a candidate will answer I and II year group papers under the year-wise pattern at the end of the second year and third year stages of study. Part-I passed Regular students of B.A. / B.Com / B.Sc. of Osmania University will be admitted into the second year of B.A. / B.Com. offered by our Centre with exemption of Language subjects with due permission from the Deputy Registrar (Academic Branch) OU. Such candidates shall have to appear first and second year optional papers under the year-wise pattern at the end of the second year. They should pay Rs. 300/-Online for language exemption.
- Candidates who have discontinued their studies as students in regular colleges and are desirous of seeking admission into second or third year B.A. through our Centre shall be permitted to offer one of the optional subjects not included in the approved combinations by private study. vii. Rules for Improvement : (B.A., B.Com and BBA)

a) Improvement during the study of the course.

A candidate who has passed in all the papers of I / II year completely can improve his/her performance in one or more papers of I / II year in the immediate next examination with provision to retain the better of the two results. A candidate after passing the III year examination completely can improve his performance by appearing for all the papers of III year in the immediate next examination and better of the two results can be retained.

b) Improvement rules after completing the course:

All such candidates who could not avail the improvement chances during the course of study as per the above rules, can avail the improvement chance after completion of the course as per the following procedure:

- i) A candidate who has passed in the papers of Part-I examination shall be permitted to appear and pass all the subjects/ papers of Part-I after passing the degree course completely.
- ii) A candidate who has completely passed the degree course shall be permitted to improve the performance in Part-II by appearing for the papers of I year or II year or III year or all the papers of three years.
- iii) A candidate is permitted to appear twice for improvement during the period of three years from the date of completion of his/ her degree.
- iv) The better of the two marks in aggregate secured by the candidates shall be taken for the purpose of improvement.

Note: These rules for improvement may change from time to time.

viii) Award of Division:

First division 60% & above Second division 50% & above and less than 60%

Pass division 36% & above and less than 50%

ix. ENROLMENT NUMBER AND IDENTITY CARD

Every candidate who is admitted to the PGRRCDE. will be assigned an Enrolment Number which will hold good during the entire period of the course. In all communications the student must invariably mention this enrolment number in full. Correspondence without enrolment number will cause delays and difficulties both to the Centre and the student and at times the Centre may not be in a position to respond. The Enrolment Number will also be used in the examination as Hall Ticket number. Every candidate admitted at the centre will also be supplied with an Identity Card by the Centre with the enrolment number. Rules of Examinations:

- i) All the examinations of Osmania University are held at Hyderabad and/ or such places and on such dates as may be notified and on website.
